**Terms and Conditions**

1. No Competition. All La Bonne Vie Senior Models agree to not represent, promote or otherwise be photographed in a promotional or marketing manner by any other Senior Portrait Photographers in Ohio, Kentucky or Indiana. The promotion of any competing photographer in the listed states automatically voids this contract, any deposits paid, and the right to view any photographer created images.
2. Free sessions. All senior models will receive two free portrait sessions. The model session is 30-60 minutes in length. It will be scheduled either on location or in the studio at the photographer's discretion. The model may choose to use one or two outfits at the model session. The session must take place before the April 15, 2009. As compensation for being a senior model, the model can receive a free senior portrait session. This session may include shoots at both the studio and on location. The extent of the free shoot is determined by the number of booked referrals at the time of the model's senior portrait session. (1) referral entitles the model to a single look in the studio (with up to two outfits). (2) referrals entitles the model to two looks in the studio with up to three outfits. (3) referrals entitles the model to three studio looks and one urban excursion on location session complimentary. The model may choose to upgrade his/her session to include more outfits, more locations or more looks for the rates specified in the 2009-2010 price list. All individual looks are as specified in the 2009-2010 pricelist.
3. Purchase requirements. Senior Models have absolutely no financial obligation to La Bonne Vie Photography. All final proofed images may be purchased at the discretion of the model, with either product credits earned through our referral program, or as cash sales payable by cash, check, Visa, MasterCard, Discover, American Express or PayPal.
4. Photographic Materials. All photographic materials, including but not limited to negatives, transparencies, proofs, and previews, shall be the exclusive property of the Photographer. The Photographer shall make proofs and previews available to the Client for the purpose of selecting photographs, but such proofs and previews do not leave the possession of the photographer.
5. Copyright and Reproductions. The Photographer shall own the copyright in all images created and shall have the exclusive right to make reproductions. The Photographer shall only make reproductions for the Client or for the Photographer's portfolio, samples, self-promotions, entry in photographic contests or art exhibitions, editorial use, or for display within or on the outside of the Photographer's studio. If the Photographer desires to make other uses, the Photographer shall not do so without first obtaining the written permission of the Client.
